ELECTION COMMISSION'S NOTIFICATION UNDER SECTION 150, AND SECTIONS 30 AND 56 OF THE REPRESENTATION OF THE PEOPLE ACT, 1951 (43 OF 1951) - APPOINTMENT OF THE DATES AND FIXATION OF HOURS OF POLL FOR THE BYE ELECTION TO THE 71-SECUNDERABAD CANTT. (SC) ASSEMBLY CONSTITUENCY, 2024.

The following Notification No. 100/TEL-LA/1/SOU3/2024 of the Election Commission of India Nirvachan Sadan, Ashoka Road, New Delhi, - 110001, Dated : 18th April, 2024/29 Chaitra, 1946 (Saka) is published.

NOTIFICATION

No. 100/TEL-LA/1/SOU3/2024:- Whereas, the seat of Ms. Lasya Nanditha Sayanina in the Legislative Assembly of the Telangana State, elected from 71- Secunderabad Cantt. (SC) Assembly Constituency has become vacant on 23rd February, 2024, by reason of her death; and

Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused;

Now, therefore, in pursuance of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-

(A) Calls upon the said 71- Secunderabad Cantt. (SC) Assembly Constituency in the State of Telangana to elect, before the 6th June, 2024 (Thursday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person belonging to any of the Scheduled Castes of Telangana State, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and

- (B) Appoints, with respect to the said election,
 - (a) the 25th April, 2024 (Thursday), as the last date for making nominations;
 - (b) the 26th April, 2024(Friday), as the date for the scrutiny of nominations;
 - (c) the 29th April, 2024 (Monday), as the last date for the withdrawal of candidatures;
 - (d) the 13th May, 2024 (Monday), as the date, on which a poll shall, if necessary, be taken; and
 - (e) the 6th June, 2024 (Thursday), as the date before which the election shall be completed, and

(C) Fixes the hours from 7.00 A.M. to 5.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.

NOTIFICATION

The 100th Constituency of the Legislative Assembly of the Telangana State, elected from VI Constituency, has become vacant on 23rd February, 2024, by reason of her death. It is hereby notified that a bye-election is to be held for the purpose of filling the vacancy as detailed below, in pursuance of Section 130 and Section 30 and 31 of the Representation of the People Act, 1951 (33 of 1951) and the Election Commission of India hereby (A) calls upon the VII Constituency (SC) Assembly Constituency in the State of Telangana to elect a candidate for the said Constituency and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a process of nomination of candidates for the purpose of filling the said vacancy is hereby invited from all eligible voters of the said Constituency.
