
NOTIFICATION

No. 100/TEL-LA/1/SOU3/2024: - Whereas, the Election Commission of India by its Notification No. 100/TEL-LA/1/SOU3/2024 dated 18.04.2024 issued under sub-section (2) of 150, and sections 30 and 56 of the Representation of the People Act-1951 (43 of 1951) has fixed the schedule and hours of poll from 7:00 AM to 5:00 PM in respect of 71- Secunderabad Cantt. (SC) Assembly Constituency; and

Whereas, having considered the request of the Chief Electoral Officer, Telangana to increase Hours of Poll in 71- Secunderabad Cantt. (SC) Assembly Segment of 7-Malkajgiri Parliamentary Constituency in view of representations received from various political parties/contesting candidates, prevailing situation of hot summer and heat wave in the State of Telangana and to increase voters' participation, the Election Commission of India has decided to increase the hours of poll in respect of aforesaid Assembly Segment of 7-Malkajgiri Parliamentary Constituency of Telangana;

Now, therefore, the Election Commission, under Section 56 of the Representation of the People Act-1951 (43 of 1951), hereby, revises earlier hours of poll of 71-Secunderabad Cantt. (SC) Assembly Constituency and fixes the hours from 7:00 AM to 6:00 PM, as the hours during which the poll shall be taken on the date specified above for the election.
