Subject: Bye-elections in various Parliamentary and Assembly Constituencies, 2021 – Clarification regarding double vaccination of Candidate/Election Agent/Polling Agent/Counting Agent/Driver etc.

Madam/Sir,

I am directed to refer various references received from States seeking clarification on the subject cited and to state that the Commission has considered the following:-

1. Candidate/Election Agent/Polling Agent/Counting Agent/Driver etc., **who has been vaccinated 1st dose** and not eligible for 2nd dose as per vaccination protocol, may be allowed with RTPCR negative report within **72 hours** of the date of poll/counting, in poll process and inside the counting hall.
2. Candidate/Election Agent/Polling Agent/Counting Agent/Driver etc., **who has not been vaccinated even 1st dose**, may be allowed with RTPCR negative report within **48 hours** of the date of poll/counting, in poll process and inside the counting hall.
3. No nomination will be denied in the absence of vaccination.

The above situation may be brought to the notice of all concerned.
