It has again come to the notice of the Commission that some Returning Officers are uploading enclosures like Aadhaar etc. alongwith the Affidavit in Form 26 on the Commission's affidavit portal.

Your attention is invited to Sections 37 of the Aadhaar Act, 2016, which provide that displaying Aadhaar data of the persons is a punishable offense.

Therefore, the Commission hereby directs that no documents other than affidavit, which have not been prescribed in the Commission's instructions, shall be uploaded on the Commission's portal. It is also directed that all such uploaded documents which contain Aadhaar details shall be identified and those details shall be either removed or masked from the Commission's portal.
