NOTIFICATION

**No.100/TEL-LA/01/SOU3/2022:-** Whereas, the seat of Shri Komatireddy Rajgopal Reddy in the Legislative  
Assembly of the Telangana State, elected from 93-Munugode Assembly Constituency has become vacant on 8<sup>th</sup>  
August, 2022, by reason of his resignation: and

Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused;

Now therefore, in pursuance of sub-section (1) of 150, and sections 30 and 56 of the Representation of the  
People Act, 1951 (43 of 1951), the Election Commission of India hereby.

(A) Calls upon the said 93-Munugode Assembly Constituency in the State of Telangana to elect, before the  
8<sup>th</sup> November, 2022 (Tuesday) and in accordance with the provisions of the said Act and of the rules  
and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative  
Assembly of the State: and

(B) Appoints, with respect to the said election,

- (a) the 14<sup>th</sup> October, 2022 (Friday), as the last date for making nominations;
  - (b) the 15<sup>th</sup> October, 2022 (Saturday), as the date for the scrutiny of nominations;
  - (c) the 17<sup>th</sup> October, 2022 (Monday), as the last date for the withdrawal of candidatures;
  - (d) the 3<sup>rd</sup> November, 2022 (Thursday), as the date, on which a poll shall, if necessary, be taken; and
  - (e) the 8<sup>th</sup> November, 2022 (Tuesday), as the date before which the election shall be completed, and
- (c) Fixes the hours from 7.00 A.M., to 6.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
