NOTIFICATION

No.100/TEL-LA/01/SOU3/2022:- Whereas, the seat of Shri Komatireddy Rajgopal Reddy in the Legislative Assembly of the Telangana State, elected from 93-Munugode Assembly Constituency has become vacant on 8th August, 2022, by reason of his resignation: and

Whereas, a bye-election is to be held for the purpose of filling the vacancy so caused;

Now therefore, in pursuance of sub-section (1) of 150, and sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby.

- (A) Calls upon the said 93-Munugode Assembly Constituency in the State of Telangana to elect, before the 8th November, 2022 (Tuesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State: and
- (B) Appoints, with respect to the said election,

- (a) the 14th October, 2022 (Friday), as the last date for making nominations;
- (b) the 15th October, 2022 (Saturday), as the date for the scrutiny of nominations;
- (c) the 17th October, 2022 (Monday), as the last date for the withdrawal of candidatures;
- (d) the 3rd November, 2022 (Thurday), as the date, on which a poll shall, if necessary, be taken; and
- (e) the 8th November, 2022 (Tuesday), as the date before which the election shall be completed, and
- (c) Fixes the hours from 7.00 A.M., to 6.00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
