ORDER :

In accordance with the provisions of Section 28 (A) of the Representation of the People Act, 1951 the following Police Officers in the State of Telangana who are involved in Law & Order and other duties connected with the conduct of Bye-Election to the Telangana State Legislative Council from Nizamabad Local Authorities' Constituency, scheduled to be held on 07th April, 2020 (Tuesday), are deemed to be on deputation to the Election Commission of India:

- x) All the Head Constables working under the jurisdiction of Nizamabad Local Authorities' Constituency.
- xi) All the Police Constables working under the jurisdiction of Nizamabad Local Authorities' Constituency.

- xii) Any other Police Officers serving for the time being in the Police Department, who are involved in any way in election related arrangements or performing duties in connection with conduct of Bye-Election to the Telangana State Legislative Council from Nizamabad Local Authorities' Constituency, scheduled to be held on 07th April, 2020 (Tuesday).

2. The above Police Officers are deemed to be on deputation to the Election Commission of India from 12th March, 2020 (Thursday) (ie., the Date of Notification) to 13th April, 2020 (Monday) (ie., the Date before which election shall be completed) or the date of declaration of result of the said election, whichever is earlier, and accordingly they shall, during that period, be subject to the control, superintendence and discipline of the Election Commission of India.
