A copy of the letter cited is sent herewith to the District Election Officers & Electoral Registration Officers of Teachers' Constituencies noted in the address entry. They are informed that the STUAP has stated that some private school managements are trying to enroll bogus electors and some bogus electors have already been enrolled in Kadapa-Anantapur-Kurnool & Prakasam-Nellore-Chittoor Teachers' Constituencies and requested to delete the bogus electors and to stop the enrolment of bogus electors.

- 2. In this connection, the attention of the District Election Officers and Electoral Registration Officers is invited to the Commissions guidelines/instructions dated: 05.09.2016 and 31.10.2016. According to the said guidelines, enrolment in Teachers' Constituency requires that the elector should have, within the six years immediately before the qualifying date (01.11.2016) for a total period of at least three years, been engaged in teaching in any of the specified educational institutions. The names of teachers of unaided / aided private school shall also be included in the electoral rolls, who intends to get his/her name enrolled in the voter list (i.e electoral roll) of the Teachers' Constituency and approaches the ERO, after getting a certificate/counter signature from the District Educational Officer that he/she is a bonafide teacher of the specified educational institution having required length of service and whose standard is not below the standard of the secondary school.
- 4. In this regard, instructions were issued to all the District Election Officers / Electoral Registration Officers to use the GPF / EPF account data as a method of verification of claims in respect of aided / unaided private schools / colleges / other educational institutions. Instructions were also issued that countersigning authorities should verify any of the supporting document viz GPF / EPF, if applicable or attendance register countersigned by the competent authorities or statement of their Bank Account indicating salary payments, acquittance rolls etc., for satisfying himself / herself about the service certificate issued by the Head of the Institution before countersigning on the service certificate. In case of Attendance Register, those registers which are countersigned by the Competent Authorities only may be accepted for verification.

- 5. It is also reiterated that the basic qualification to enroll the elector besides teachers' qualification is that he should be ordinary resident of the respective Teachers' Constituency. His name should be enrolled in the polling station of the Constituency based on his residence, but not at his working place. Thus, the ordinary residence within the said Teachers' Constituency is mandatory and the working place is not the criteria for registration as voter in a particular constituency.
- 6. The District Election Officers and Electoral Registration Officers are, therefore, requested to verify whether any person has been enrolled without submitting the Service Certificate issued by the Head of the educational institutions duly countersigned by the District Educational Officer in respect of private unaided / aided schools or equivalent officer in respect of private colleges / other educational institutions, if not, take further action for deletion of such names following the due process. In case it is found that the Head of the Institution / Countersigning Authority has given false information in the Certificate, action shall be taken against such Head of the Institution / Countersigning authority under Section 31 of the Representation of People Act, 1950. The name of the elector should be enrolled in the relevant polling station based on his/her ordinary residence, but not the place of working.
- 7. It is further informed that draft Electoral Rolls have been placed on CEOs' web sites and it can be downloaded by anyone. The DEOs are requested to give wide publicity about this facility. Hard copies of the electoral rolls and soft copy containing pdf roll without photographs can be shared with any person / association on payment basis, as in the case of Assembly Electoral Rolls.
- 8. All the District Election Officers / Electoral Registration Officers of Teachers' Constituencies are requested to bring these instructions / clarifications to the notice of all concerned.

The District Election Officers and the Electoral Registration Officers of Council Constituencies noted in the address entry are informed that certain Teachers' Unions, Associations, Political Parties and Public Representatives have represented that large number of names are not finding place in the draft electoral rolls, eventhough the applicants have filed applications and got acknowledgements, that the authorities have not enrolled the applicants who have furnished the Flat number instead of municipal / panchayat house number; that the details of educational institutions where the applicant/elector is working have not been incorporated in the draft electoral roll and requested to issue necessary instruction to all concerned in this regard. The Collector & DEO, Vizianagaram has also reported that data entry could not be done in respect of 2566 applications due to paucity of time and requested to accord permission for data entry. Accordingly, the following instructions / clarifications are issued based on the statutory provisions / ECI instructions:

### (i) Data entry of pending applications:

Instructions have been issued to all the DEOs / EROs to enter all applications received in ERMS invariably without leaving even a single application and all applications received shall be verified by the BLOs / Verifying Officers with reference to the ordinary residence of the applicants and their names shall be enrolled in the polling station where the residence of the applicant falls. It is evident that certain number of

applications are not entered in the ERMS before draft publications, which led to these complaints from the applicants that their name is not found in the draft electoral rolls.

The DEOs / EROs are, hereby, again instructed to get all the applications entered in the ERMS which are pending at the time of draft publication during the claims and objections period along with the applications, which were rejected also, if not done already.

For the rejected applications, the reason for rejection shall be updated invariably for each and every application, so that the applicant can know the reason and to file fresh application / appeal with supporting documents.

## (ii) Enrolment of teachers working in private unaided / aided educational institutions:

The District Election Officers and Electoral Registration Officers are instructed to verify whether any person has been enrolled without submitting the Service Certificate issued by the Head of the educational institutions duly countersigned by the District Educational Officer in respect of private unaided / aided schools / colleges / other educational institutions, if not, take further action for deletion of such names following the due process. In case it is found that the Head of the Institution / Countersigning Authority has given false information in the Certificate, action shall be taken against such Head of the Institution / Countersigning authority under Section 31 of the Representation of People Act, 1950. The name of the elector should be enrolled in the relevant polling station based on his/her ordinary residence, but not at the working place.

### (iii) Rejection of applications having Flat No.:

The applications with valid house number / Flat No., which can be identifiable should not be rejected. The BLO should obtain the Municipal / Panchayat house number at the time of field verification and incorporate the same in the application / ERMS, but the application shall not be rejected only on this ground.

## (iv) Details of educational institution where the applicant is working / worked in the draft roll:

It has come to the notice that large number of entries in the draft electoral roll of Teachers' Constituencies are not having the details in the column "School / College where teaching". All the fields mentioned in the ERoll format are mandatory and no column should be left blank or incomplete. All the DEOs / EROs are, therefore, instructed to verify the draft electoral rolls and fill up all the blank columns including the column "School / College where teaching" immediately and furnish such lists after data entry to all the political parties repeat all the Political Parties to enable them to file objections, if any.

All the District Election Officers / Electoral Registration Officers of Teachers' Constituencies are requested to bring these instructions / clarifications to the notice of all concerned and send the compliance report.

The District Election Officers and Electoral Registration Officers of the Teachers' Constituencies noted in the address entry are informed that the State Secretary, CPI (M) & President, APUTF in their letters cited have represented in connection with the preparation of electoral rolls of Graduates' & Teachers' Constituencies stating that —

- Every application registered along with the certificate should be placed online till the completion of election to raise objections;
- ii) List of Registered electors shall be put online on day to day basis;
- iii) Details of rejected voters along with reasons for rejection shall be placed online and to supply the hard copies to the political parties and besides making hard copies available to others as per procedure;;
- iv) Issue circular instructions to the effect that objections can be filed till the elections;
- 2. They have further complained that all applications filed online are accepted without any enquiry and names are enrolled in the voters list even if applicants do not possess any qualification and did not furnish the information required, thus requested to accept the applications only after thorough verification whether applications are received online or physically.
- 3. In view of the above, the following instructions are issued to the District Election Officers and Electoral Registration Officers for strict compliance:
  - i) The facility of preparing Polling station wise list of claims and objections with drill down to individual application form & certificate attached without photograph has been provided on the website of the Chief Electoral Officer including the facility for status checking of each application form. The DEOs & EROs to check the same, generate the list & make available to all the Political Parties with the information available on website;

- ii) Facility for searching the name in the electoral roll has been provided based on House number and name of elector on the website of the Chief Electoral Officer. It has to be notified to all the Political Parties besides wide publicity to the Public.
- iii) The list of rejected applications along with reasons for rejection shall be made available to the public by the ERO on the web site, in his office / offices of DEOs / AEROs / Designated Officers / BLOs / Gram Panchayats and Municipalities in order to enable the aggrieved to file appeals / fresh applications with proper documents;
- iv) Hard copies of such lists shall be shared with the political parties;
- v) The existing provisions of Section 22 and 23 of the R.P. Act, 1950, read with rule 26 of the RER,1960 permit continuous updation of electoral roll even after final publication of electoral roll. As per these provisions, such updation can take place upto 3.00 p.m. of the last date of filing nomination for an election. As such, the persons whose names would not find place in the electoral rolls or objections are filed for enrolled names, they can file their applications / objections till the last date of filing nominations for an election;
- vi) However, in order to comply with the statutory provision of the Representation of People Act, 1950 and Registration of Electors Rules. 1960 as mentioned in para 3(v) supra, while disposing of the applications and preparation of supplement under continuous updation, as clarified by the Commission, it is not necessary to dispose of all the applications filed upto the last date for filing nominations and include them in the Supplement to be brought before elections. To comply with the legal requirements of sub-rule (3) & (4) of rule 26 of RER 1960 and also for administrative reasons, only the applications received atleast ten days prior to the last date for filing nominations should be disposed of. This is because the date of posting of the application on the Notice Board by the ERO for inviting objections under sub-rule (3) should be excluded while computing the mandatory period of seven days within which objections can be filed by any person. One more day is required to dispose of the application under sub-rule (4) thereof. One more day would be required to make necessary entries in the Registers prescribed for the purpose and preparation of manuscript for data entry.
- 4. It is further re-iterated that without proper enquiry, no application shall be accepted or rejected whether received online or physically. All applications shall be thoroughly verified with reference to the ordinary residence of the applicant by the BLO as well as the Service Certificate / countersignature in case of Private Teacher-electors as already instructed.

5. All the District Election Officers / Electoral Registration Officers of Teachers' Constituencies are requested to bring these instructions / clarifications to the notice of all concerned for strict compliance.

Whereas, the said list is being adopted for Telangana State till date after bifurcation of united Andhra Pradesh consequent on enactment of A.P. Reorganization of Act, 2014 and it requires modifications in respect of nomenclature of certain institutions and addition of new institutions:

The attention of all the District Educational Officers in the state reference read above, the Government has informed that every person who is a citizen of India, and is ordinarily resident in the constituency and has, within the six years immediately before 1st November, 2016 been angaged for a total period of at least three years in teaching in any of the educational institutions, within the state specified to be not lower in standard than that of a secondary school is eligible to be included in the electoral roll. Every application in Form 19 by a person seeking enrolment in Teachers Constituency shall be accompanied by a certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years within the last preceding six years.

The engagement of a person in teaching in the Secondary Schools Recognised by the Government for at least three years within the preceding six years may be either in one continuous spell or in broken spells and further, may be either in one institution or more institutions, but all such institutions must be Recognised Secondary Schools by the State Government. Therefore, it is immaterial whether a person, who has been so engaged in teaching for a total period of three years in one or more Recognised Secondary Schools by the Government, has been employed in those institutions as teacher on regular basis or on ad-hoc basis but he should be whole time teacher. Part-time teachers are not eligible for enrollement in the electoral rolls for Teachers' Constituency.

Therefore, all the District Educational Officers in the State are directed to counter signing the certificate issued by the Heads of Secondary Schools Recognised by the Government up on satisfying themselves regarding Bonafides of the teachers as per Attendance Registers; Salary payment acquittance/ Bank Statement; Service Records etc.

The District Election Officers & Collectors of Srikakulam, Viziangaram, Visakhapatnam, Prakasam, Nellore, Chittoor, Kadapa, Anantapur and Kurnool districts of Andhra Pradesh, Mahabubnagar & Ranga Reddy in Telangana and the Commissioner, GHMC & DEO, Hyderabad and the E.R.Os of Srikakulam-Viziangaram-Visakhapatnam Graduates', Prakasam-Nellore-Kadapa-Anantapur-Kurnool Graduates; Chittoor Graduates'. Kadapa-Anantapur-Kurnool Teachers' Teachers', Nellore-Chittoor Mahabubnagar-Ranga Reddy-Hyderabad Teachers' Constituencies informed that certain Teachers' Unions, Associations, Political Parties and Public Representatives have made certain requests and suggestions in connection with the preparation of electoral rolls of Graduates' & Teachers'

Constituencies. Accordingly, the following instructions / clarifications issued based on the statutory provisions / ECI instructions:

### (i) Denovo Preparation of Electoral Rolls

The electoral rolls of Graduates' and Teachers' constituencies of Legislative Councils, shall be prepared *de-novo* under rule 31 of the Registration of Electors Rules, 1960 immediately before every election requiring all eligible persons including those electors already enrolled in the then existing electoral rolls, who shall apply afresh in Form-18 / Form-19, as the case may be, to the concerned EROs alongwith copy of relevant documents and the Election Commission has also issued instructions. As such, all persons whose names are included in the existing rolls **should also submit fresh** application in the prescribed Form-18/19.

## (ii) Enrolment of teachers working in private unaided / aided educational institutions:

According to ECI instructions, teachers working in unaided private schools and aided schools are also eligible to be included in the electoral rolls of Teachers' Constituency, if they fulfil other conditions and submit required certificate issued by the Head of the Institution and get countersigned their applications by the District Inspector of Schools / District Educational Officers in these two States. Instructions have already been issued that the certificate of the Head of the Educational Institution countersigned by the District Educational Officer or the equivalent officer of the Intermediate / Collegiate Education Department in respect of Intermediate / Degree Colleges / Universities should be considered enough by the ERO to determine the eligibility of the applicant. In case, the Head of educational Institution is the applicant, the self Service Certificate can also be issued in the name of the Head of the Educational Institution.

It is further clarified that the ECI has not authorized to countersign the Certificates issued by the Heads of Institutions by the Mandal Educational Officer. Only certificates countersigned by the District Educational Officer or equivalent officer in case of Intermediate Colleges / Universities etc. shall be allowed. The countersigning authority should verify any supporting document viz GPF / EPF, attendance register, statement of their Bank Account indicating salary payments for satisfying himself / herself about the claim before countersigning on the certificate.

The Director of School Education, Telangana has issued instructions to all the District Educational Officers for countersigning the certificate issued by the Heads of Secondary Schools recognized by the Government upon satisfying themselves regarding bonafides of the teachers as per Attendance Registers, Salary payment acquittance / Bank Statements / Service Records and other conditions as laid down in Sub-Rules (8) and (9) of Rule 12 of G.O.Ms.NO.1, Education (PS.2), dt.1.1.94

as amended from time, vide their Proceedings No.807/Plg.I/2016, dt.22.10.2016 & 27.10.2016. Copies of the same are enclosed herewith for strict compliance. Any deviation in this regard, will be viewed seriously.

The Head of the Institution / Countersigning authority should be cautioned about the penal provisions of R.P.Act, 1950 for giving false information. In case it is found that the Head of the Institution / Countersigning Authority has given false information in the Certificate, action shall be taken against such Head of the Institution / Countersigning authority under Section 31 of the Representation of People Act, 1950.

The Electoral Registration Officer shall also cross-verify with the Heads of the educational institutions for satisfying the eligibility of an applicant on the basis of any record available with the Head of the institutions besides Service Certificate issued by the Head of the Institution.

### (iii) Furnishing of residential proof:

According to ECI guidelines, the applicant has to submit Form-18 / 19 as the case may be along with supporting document authenticated by the officers / certificates issued by the Heads of Institutions countersigned by the Dist.Ednl.Officer or equivalent Officer. The applicant may also submit any document in support of residential proof, but it is not mandatory to submit along with the application. However, the Booth Level Officer should necessarily make field visits to verify whether the applicants are ordinary residents of the respective Council Constituency based on the residential address provided in the application, if not, such applications shall be rejected.

The applicants can get their name enrolled, if eligible, in the place where they are ordinarily resident during this period. It is not necessary that the educational institution in which an eligible elector is employed should also fall within the same Teachers' constituency. The eligibility to be enrolled in a particular Teachers' constituency should be determined on the basis of the applicants' place of ordinary residence and not on the basis of his place of work.

## (iv) Receipt of applications submitted by the Teachers to the Designated Officers at place of working:

The applications can be received from the Teachers-applicants by the AEROs / Designated Officers in the working area of the Teachers, eventhough the residential area falls in jurisdiction of other AERO / Designation Officer. However, such applications shall be segregated based on the residential address and forwarded to the respective ERO / AERO / Designated Officers for verification immediately.

### (v) Receipt of applications by the MDOs / MEOs :

It has come to the notice that the applications in Form-18 / 19 are received by Mandal Revenue Officers only and Mandal Education Officers / Mandal Development Officers are not receiving the applications. The Dist.Election Officers / EROs shall issue instructions to all the MEOs / MDOs to receive the applications duly appointing them as Designated Officers and communicating the ECI instructions.

## (vi) Submission of applications in bulk through online and with fake certificates in respect of Graduates' Constituencies:

It is reiterated that all the applications received online should be thoroughly verified by the Booth Level Officer / Verification Officer. The verification officer should visit the residence of the applicant, get the signature of the applicant on the application and get the certificates regarding educational qualification in respect of graduates verified with originals and after satisfying himself / herself, shall record either "Verified with original and found correct" or "Verified with original and found not correct — may be rejected" and affix signature with full name and PIN number, if any, on the application. In respect of Teachers applications, besides taking signature, the original Service Certificate issued by the Head of the Institution should be authenticated.

# (vii) Enrolment of Secondary Grade Teachers working in Govt./ZP/Aided/Municipal Schools, Teachers working in Model Schools / Kasturibha Balika Vidyalayas:

It is clarified that every teacher who has been engaged in teaching for the qualified period in an educational institution coming up to the prescribed standard will be entitled to be registered as an elector, irrespective of whether he is teaching in the primary section, middle section or any other section of the institution. It is also immaterial whether the person is Secondary Grade Teacher or School Asst., or with any other designation so long as he / she is working in the institutions notified vide G.O.Ms.No.537, G.A. (Elecs.F) Dept. dt.28.09.2006 and G.O.Ms.No.644, General Admn. (Elecs.F) Dept., dt.09.11.2006. In respect of Model Schools / Kasturibha Balika Vidyalayas, views of the School Education Departments of both the State Governments are awaited.

### (viii) Extension of last date for filing applications in Form 18 / 19:

Rule 31 (3) of the Registration of Electors Rules, 1960 provides for receipt of applications in Form-18 or Form-19, as the case may be, for inclusion of name in the Council Constituencies before 7<sup>th</sup> day of November. Hence, the Election Commission of India may not consider the request for extension as it is against the provision of Rule 31 of the Registration of Electors Rules, 1960.

The DEOs / EROs shall give wide publicity with regard to last date for receipt of the applications as 05.11.2016 through media / Political Parties / Teachers Unions / Associations and also to take necessary action to establish more number of centres / places for receiving applications, since there will be huge response during last days.

All the instructions / clarifications issued by this office / ECI have been placed on CEO's web sites. All the District Election Officers / Electoral Registration Officers of Teachers' Constituencies are requested to bring these instructions / clarifications to the notice of all concerned.

- (a) Draft electoral roll is having repeated names and such duplicate names shall be removed:
- (b) Some names of teachers working in Primary Schools were enrolled and such names shall be deleted;
- (c) Some Graduates' and non-teachers' who have applied for enrolment in Graduates' Constituency have been enrolled in Teachers' Constituency and such names shall be verified and deleted;
- (d) details of educational institutions where the applicant/elector is working have not been incorporated in the draft electoral roll in many cases;
- (e) Ineligible teachers' working in private institutions have been enrolled;
- (f) Names of the teachers' working in private educational institutions have been included in the absence of the service certificate countersigned by the competent authority;

- (g) The draft electoral roll contains many errors;
- (h) To verify every application received for enrolment of teachers' through special officers
- (i) The draft roll contains the electors with age of 24 years and below and according to guidelines, there should be three years gap for enrolment;

In view of the above complaints / requestes, the following instructions are reiterated / issued to all the DEOs / EROs:

- (i) to verify the draft electoral rolls and fill up all the blank columns including the column "School / College where teaching" and mention the full particulars / address of the institutions and update the full name of the elector, where only surname has been printed immediately. Such corrected lists shall be made available in DEO / ERO / AERO offices and shall be supplied to Political Parties. Such copies can be shared with the individuals / Teachers' Unions on payment basis.
- (ii) to verify whether any person has been enrolled without submitting the Service Certificate issued by the Head of the educational institutions duly countersigned by the District Educational Officer or equivalent Officer in respect of private unaided / aided schools / colleges / other educational institutions and whether any ineligible elector is enrolled, if not, take further action for deletion of such names following the due process.
- (iii) In case it is found that the Head of the Institution / Countersigning Authority has given false information in the Certificate, action shall be taken against such Head of the Institution / Countersigning authority under Section 31 of the Representation of People Act, 1950. If any ineligible person is enrolled in Teachers' Constituency, action should be taken for deletion of such names keeping in view of the instructions already issued duly following the due procedure.
- (iv) In all such cases, the District Election Officer should send specific report on the persons responsible for such serious lapse for initiating disciplinary / criminal action under Electoral Laws.
- (v) Each and every application should be thoroughly verified by the Booth Level Officer or Verifying Officer to ascertain the "ordinary residence" of the elector and also to verify the supporting documents submitted along with the application. Without proper enquiry, the application shall not be accepted or rejected. If any instance of enrolment of ineligible elector comes to the notice of this office, stringent action will be initiated against the officers responsible.

All the District Election Officers / Electoral Registration Officers of Teachers' Constituencies are requested to bring these instructions / clarifications to the notice of all concerned and send the compliance report.

- 1. The Government in reference first cited, stated that every person who is a citizen of India, and is ordinarily resident in the constituency and has, within the six years immediately before 1st November, 2016 been engaged for total period of lead three years in teaching in any of the educational institutions, within the State specified to be not lower in standard than that of a Secondary School is eligible to be included in the electoral roll. Every application in Form 19 by a person seeking enrolment in Teacher's Constituency shall be accompanied by a certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years with in the last preceding six years. The said period may be either in one continuous spell or in broken spells and further, may be either in one institution or more institutions, but all such institutions must be specified by the State Government.
- 2. Therefore, it is immaterial whether a person, who has been so engaged in teaching for a total period of three years in one or more specified education institutions, has been employed in those institutions as teacher on regular basis or on ad-hoc basis but he should be whole time teacher (even if there is no sanctioned post) and not engaged on a part-time basis as the condition for three years engaged on a part-time basis as the

Condition for three years engagement in teaching cannot be fulfilled by a part-time teacher. Part-time teachers are not eligible for enrolment in the electoral rolls for Teachers constituency.

- **3.** In this connection, the Govt., requested to furnish information on their Officers whom they have identified as Countersigning Authorities under intimation to the Govt.
- **4.** Instructions earlier issued in reference second read above stand cancelled.
- 5. The Principals of GDCs shall issue Service Certificates only with respect to Government Degree Colleges. Countersigning of Certificates will be done by Principals of ID.Colleges. The Service Certificates issued by the Correspondent/Principal of Aided Degree Colleges for Grant in aid Teaching Staff may be countersigned by Identified College Principals.
- 6. Regarding Private Unaided Degree Colleges and Unaided Staff of Pvt.Aided Colleges, Principals of GDCs shall not issue any Certificate or Counter Sign Service Certificates. Related to Staff of Pvt.unaided Colleges, as they shall be issued by concerned Universities.
- 7. As this is made amply clear by the Govt., in their Letter at reference 3<sup>rd</sup> read above, addressed to the V.Cs of Universities in State to specify the Officers, who will be 'Countersigning' authorities in r/o.the University Colleges and Affiliated Colleges. The V.Cs were requested by the Govt., to issue instructions to all such Officers for 'Countersigning' the Certificates issued by the Heads of Educational Institutions, upon satisfying themselves regarding the services indicated of the Teacher under intimation to the Govt.
- 8. In view of above, the instructions issued in paras 5 to 7 shall be followed by the Principals of Identified Government Degree Colleges in the 30 Districts in the State in connection with the preparation of electoral rolls of Teachers Constituency. Identified to countersign on the service certificate of the applicant issued by the Head of the Institutions in respect of Government Degree Colleges & Grant in aid post of Private Aided Degree Colleges only. Regarding Service Certificate of unaided Lecturers in Pvt.Aided Colleges, the University concerned are competent authority.
- **9.** While countersigning on the service certificates, the instructions mentioned below may be followed.

- 1) Service Certificates of full time Lecturers of Govt.Colleges and Service Certificates of full time Lecturers in Grant in aid in Private Aided Colleges shall only be examined & Counter signed.
- 2) Evidence of Attendance and the payment of their salaries in their Bank accounts of these Teachers etc., may be verified.
- 3) Any other evidence like S.R etc., may be examined to confirm or Countersign whenever required.
- 4) In case of any dispute or discrepancy or indefinite evidence may be referred to RJDCE, Warangal immediately.

Therefore, all the Principals of Identified GDCs & RJDCE, Warangal are requested to scrupulously follow the guidelines issued as the Electoral Rolls of 1 Teachers' Constituency of Telangana Legislative Council with reference to 01.11.2016 as the qualifying date is time bound as stipulated by Election Commission of India.

Every application in Form 19 by a person seeking enrolment in Teachers' Constituency shall be accompanied by a Certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years within the last preceding six years.

- 2. The engagement of a person in teaching in the specified Educational Institutions for at least three years within the preceding six year may be either in one continuous spell or in broken spells and further, may be either in one Institution or more Institutions, but all such Institutions must be specified by the State Government. Therefore, it is immaterial whether a person, who has been so engaged in teaching for a total period of three years in one or more specified Educational Institutions, has been employed in those Institutions as teacher on regular basis or on ad-hoc basis but he should be whole time teacher (even if there is no sanctioned post) and not engaged on a part—time basis as the condition for three years engagement in teaching cannot be fulfilled by a part-time teacher. Part-Time teachers are not eligible for enrolment in the Electoral Rolls for Teachers' Constituency.
- 3. In the light of the Order of the Hon'ble High Court of Allahabad (Lucknow Bench) dt. 5th March, 2008 in Writ Petition No.1269 (M/B) of 2008 (Madhyamic Vitta Viheen Vidyalaya Prabandhak Mahasabha Vs State of Uttar Pradesh), the Election Commission of India has instructed that the name of such teacher of Unaided Private School (if it is covered by the list of specified Educational Institutions) shall also be included in the Electoral Roll who intends to get his/her name enrolled in the voter list (i.e., Electoral Roll) of the Teachers' Constituency and approaches the ERO, after getting a Certificate/Counter

signature from the District Inspector of Schools that he/she is a bonafide teacher of the specified Educational Institution having the required length of service and whose standard is not below the standard of the Secondary School.

- As such instructions were issued to the District Election Officers that the Certificate of the Head of the Educational Institutions Countersigned by the District Educational Officer or the equivalent Officer of the Intermediate /Collegiate Education Department in respect of Intermediate/ Collegiate /Universities should be considered enough by the ERO to determine the eligibility of the applicant. But, in case of any doubt, the Electoral Registration Officer has to cross-verify with the Heads of the Educational Institutions for satisfying the eligibility of an applicant on the basis of any record available with the Head of the Institutions besides Service Certificate issued by the Head of the Institution.
- Officer are not countersigning on the Service Certificate issued by the Head of the Institutions in connection with the preparation of Electoral Rolls of Teachers' Constituency stating that no instructions were receive in this regard and requested to issue instructions to the District Educational Officers for Countersigning in respect of Private Un-aided Schools. They have also requested to specify the Officers, who will be Countersigning authorities, in respect of Junior Colleges, Degree Colleges, Medical, Engineering Colleges, Polytechnic Colleges, Universities and issue instructions to all concerned.
- 6. You are therefore requested to specify the Officers, who will be 'Countersigning' authorities in respect of the University Colleges and Affiliated Colleges and issue instructions to all such Officers for 'Countersigning' the Certificates issued by the Heads of Educational Institutions, upon satisfying themselves regarding the service indicated of the Teacher under intimation to the Government. These Officers may verify the evidences of attendance of these Teachers in the Private Un-aided Institutions, the payment of their salaries in their bank account etc., as a suggestion. They may examine any other evidence which you would like your 'Countersigning' Officer to see before 'Countersigning' these Certificates Issued by the Principals of Un-aided Colleges.
- 7. You must inform to the Government the instructions issued in this regard to the Officers identified by you as 'Countersigning Authorities' urgently so that the same can be informed to the Election Commission of India since the entire process of Registration of Voters is getting completed by 05-11-2016.

In continuation to the letter 1st cited above, the Registrar, Satavahana University in his letter 4th cited has informed that they have nominated Prof.M.Komal Reddy, Dean, CDC, Satavahana University, Karimnagar as the 'Counter Signing Officer' to verify the Certificates of the Teachers issued by the University Colleges and Affiliated Colleges. Similarly, the Registrar, Mahatma Gandhi University in his letter 3rd cited has informed that they have nominated Dr. Aluvala Rayl, Associate Professor & Director Academic Audit Cell of Mahatma Gandhi University, Nalgonda as 'Counter Signing Authority'. But, these Universities have not mentioned whether they are Counter Signing Authority for the University Colleges only or all the Affiliated Colleges also. Counter Signing Authority is needed mainly for the Affiliated Colleges.

- The Registrar, Telangana University in his letter 5th cited las informed that they have nominated Prof.P.Kanakaiah, Principal of the University College of Arts & Sciences as the Counter Signing Authority. They have also not mentioned whether he is the Counter Signing Authority for the University Colleges only or for all the Affiliated
- 3. Meanwhile, the Jawaharlal Nehru Technological University, Hyderabad has issued instructions in the matter vide their letter 2<sup>nd</sup> cited. A copy of this letter is enclosed. The Vice Chancellor, Jawaharlal Nehru Technological University, Hyderabad must instruct his Counter Signing Officers / Faculty about the conditions mentioned in the reference 1st cited also.
- Therefore, all the Vice-Chancellors of the Universities mentioned in the address entry are requested to issue similar instructions immediately nominating their Faculty Member as Counter Signing Authorities. Before Counter Signing, these Faculty Members must verify all the aspects as mentioned in the letter enclosed regarding JNTU i.e., they must verify Enclosures to the Certificates issued by the Principals of Affiliated Colleges as follows:-
  - Experience Certificate.
  - 2. Evidence of Attendance of the Teacher.
  - 3. Statement of payment of the salaries in the Bank Account of 4. IT Traces/Form-16.

  - 5. The Counter Signing Authority must verify the above and also the staff Bio-Data as available in the University Faculty Portal. Because the Private Educational Un-aided Institutions have to maintain the Record of their Faculty which they have to send to their Affiliating University.
  - 6. The other conditions as mentioned in the letter of the Government, dt.24.10.2016 addressed to all the Vice-Chancellors in the reference 1st cited must also be verified.
- Therefore, the Counter Signing Authorities must be identified by the Vice-Chancellors and the instructions issued in this regard very urgently since the matter is delayed already, with a copy to the Government, so that the Election Commission can be informed regarding the same, since the entire process of Registration of Voters
- Regarding Dr.B.R.Ambedkar Open University, received from the Registrar of the University in the reference 7th cited is found in order because they don't have any Affiliated Colleges. Prof.S.V.Rajasekar Reddy, Director (Academic) is the University Dr.B.R.Ambedkar Open University must give clear instructions to Prof.S.V.Rajasekar Reddy regarding various aspects as mentioned in the above paras which he must check before he Counter signs.

- 7. Similarly, the Vice-Chancellor, Potti Sree Ramulu Telugu University, Hyderabad in the reference  $6^{\text{th}}$  cited has also nominated his Registrar as the Counter Signing Authority. He should also be given clear instructions to verify the various aspects as mentioned in the above paras.
- 8. In the case of the RGUKT University, no letter is received from the Vice-Chancellor. As the University does not have any Affiliated Colleges, the Vice-Chancellor must identify and inform the Government about the Faculty Member who would be the Counter Signing Authority and before should verify the various aspects as mentioned in the above paras of this letter.
- 9. No reply is received from the Vice Chancellors of Osmania University, Hyderabad / Kakatiya University, Warangal/Palamuru University, Mahabubnagar/ Jawaharlal Nehru Architecture and Fine Arts University, Hyderabad. They are requested to take necessary action on the above urgently.
- 10. All the Vice Chancellors of the 11 Universities mentioned above are finally requested to nominate the Faculty / Officers for Counter Signing and give instructions as above immediately, under intimation to the Government by 29.10.2016.

Any further delay in the matter will have to be viewed seriously as it is an important task of the Election Commission and the entire process has to be completed by 5.11.2016.

Through the reference cited, the Special Chief Secretary to Government, Telangana Secretariat, Hyderabad has informed that every person who is a citizen of India and is ordinarily resident in the constituency and has, within the six years immediately before 1<sup>st</sup> November, 2016 been engaged for a total period of atleast three years in teaching in any of the Educational Institutions, within the State specified to be not lower in standard than that of a Secondary School is eligible to be included in the Electoral Roll. Every application in Form 19 by a person seeking enrolment in Teachers' Constituency shall be accompanied by a Certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years within the last preceding six years.

The engagement of a person in teaching in the specified Educational Institutions for atleast three years within the preceding six years may be either in one continuous spell or in broken spells and further, may be either in one Institution or more Institutions, but all such Institutions may be specified. Therefore, it is immaterial whether a person, who has been so engaged in teaching for a total period of three years in one or more specified Educational Institutions, has been employed in those Institutions as teacher on regular basis or on ad-hoc basis but he should be whole time teachers (even if there is not sanctioned post) and not engaged on a part-time basis as the condition for three years engagement in teaching cannot be fulfilled by a part-time teacher. Part-Time teachers are not eligible for enrolment in the Electoral Rolls for Teachers' Constituency.
