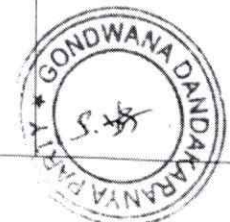

1. It may be noted that in case the party intends to contest election in all parliamentary/assembly constituencies of a State, the party will have to submit an Affidavit duly notarized and signed by the President or General Secretary or a person holding equivalent level position in the party, as per specimen attached at Annexure-II

2. It may also be noted that the concession of allotment of common symbol to the candidates of a registered un-recognised party under the paragraph 10B of the Election Symbols (Reservation & Allotment) Order, 1968 shall be available to a party only at any **two** general elections to the House of People, **or** any **two** general elections to a State Legislative Assembly or at one general election to the house of the People and the other at a general election to a State Legislative Assembly, as the party may choose. However, if the Party has polled 1% of votes in the last occasion, it can apply again.


