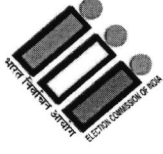


NOTIFICATION

No. 100/TL-LC/02/2020-LAC: - WHEREAS, the Commission, vide its Notification No.100/TL-LC/02/2020-LAC, dated 24th March, 2020, in exercise of its powers conferred under Article 324 of the Constitution of India read with section 153 of the Representation of the People Act, 1951, extended the time for completion for the bye election to Telangana Legislative Council from Nizamabad Local Authorities' Constituency by 60 days from date of that notification.

And Whereas, the Commission, after reviewing the matter in terms of the extant COVID-19 containment guidelines (issued by the Chairperson National Executive Committee under the Disaster Management Act, 2005 on 17.05.2020) which has extended the lockdown up to 31.05.2020, in exercise of its powers conferred under Article 324 of the Constitution of India read with section 153 of the Representation of the People Act, 1951, has directed that the period for completion of the said bye-election is further extended by 45 days.

Now, therefore, the Commission amends its Notification No.100/TL-LC/02/2020-LAC dated 12th March, 2020 to the extent that the date of completion of the said bye-election is further extended by 45 days from the date of this notification. Fresh date of poll, counting etc., all subsequent activities shall be notified in due course after reviewing the situation further.
