Sir/Madam,

In continuation of Commission's letter of even no. dated 02.02.2021 on the subject cited, I am directed to state that under Para 5.1 of the guidelines for Voting through postal ballot by Absentee Voters in the category of Senior Citizens, PwDs and Covid-19 suspect or affected persons, the Commission has directed that teams of poll officers, comprising two officials out of which at least one should be not below the rank/level of the official appointed as polling officer for Polling Station in the State, should be appointed for the purpose of briefing of electors and collection of marked ballot papers. Now, the Commission has decided that a micro observer will also accompany the above said teams of poll officers.

This may be brought to the notice of all District Election Officers, Returning Officers and other election authorities concerned, for their information.
