### Notes forming part of Financial Statements

#### l Basis of preparation of financial statements

The financial statements of the Company have been prepared on cash basis.

#### Il Fixed assets (Tangible / Intangible)

Fixed assets are carried at cost less accumulated depreciation/amortisation. The cost of fixed assets comprises its purchase price net of any trade discounts and rebates, any import duties and other taxes (other than those subsequently recoverable from the tax authorities), any directly attributable expenditure on making the asset ready for its intended use and other incidental expenses.

#### III Revenue Recognition

The party recognises its receipts from voluntary donations, weather general or specific, membership fees, interest income and other incidental income on cash basis as and when it is actually received.

#### IV Expenditure

The party recognises its expenses on cash basis as and when payment is disbursed, advances paid or availed are also recognised on cash basis.

# V Depreciation and Amortisation

- (i) Fixed assets are depreciated on Written Down Value (WDV), as per the Income Tax Act, 1961.
- (ii) All categories of assets costing less than Rs 5,000 each, mobile phones, Tablet devices and items of soft furnishing are written off in the year of capitalization.
