






Note No: 20 Significant Accounting Policies and Notes on Accounts for the Financial Year 2022-23.

- 1. Nature of Operations: Indian National Yuva Jana Party is a Registered Political Party under the Representation of People Act. 1951 with Election Commission of India Vide No.56/66/2019-19/PPS-1.
- 2. Basis of Preparation: Financial Statements have been prepared as of a Going Concern on historical cost convention and on accrual method of accounting in accordance with the generally accepted accounting principles followed in India and Accounting Standards as issued by the ICAI. Guidance Note on Accounting and Auditing of Political Parties issued by ICAI during the year 2012 has been followed by the Political Party, for preparation and presentation of Financial Statements.
- 3. Property, Plant and Equipment: All Property, Plant and Equipment are started at historical cost of acquisition less accumulated depreciation and impairment loss, if any. All Costs including financing costs and revenue expenditure incurred on fixed assets till the assets are put to use have been capitalized to the respective assets.
- 4. **Depreciation:** Depreciation on Property, Plant and Equipment has been charged as per Written down Value Method at the rates and in the manner specified in the Income Tax Act. 1961 and rules framed there under.
- 5. **Impairment of Assets:** The party recognized impairment loss in the year in which the assets are identified as impaired. There is no impairment loss recognized during the year.
- 6. Revenue Recognition: Revenue is recognized to the extent that is probable that the economic benefits will flow to the Entity and the revenue can be reliably measured.

The party recognizes its receipts from Membership Fee, Voluntary Donations / Contributions whether General or Specific on receipts.

- 7. Expenditure: Expenses are recognized only when the future economic benefits are measured reliably.
 - a. All Revenue expenditure has been accounted under Accrual Concept.
 - b. Capital expenditure is accounted under accrual and initially recorded as Work in Progress and capitalized to the respective asset from the date when it is put to use.





- 8. Income Tax: The Party has complied with the applicable provisions of Income Tax Act, 1961 and the Representation of People Act. 1951 and accordingly eligible for exemption of its income from payment of income tax. Hence no provision for Income tax has been made.
- 9. Estimates: The Preparation of Financial Statements are in conformity with the generally accepted accounting principles required management to make estimates and assumptions that affects the reported amount of assets and liabilities and disclosures at the date of the Financial Statements. Although these estimates are based on upon management's best estimate and knowledge of current events action, actual results could differ from these estimates.
- 10. Provisions: A provision is recognized when the party has present obligation as a result of past event, it is probable that an outflow of resources embodying economic benefit will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are based on the estimates required to settle the obligation at the Balance Sheet date and are adjust to reflect the current best estimates.
- 11. Contingent Liabilities: There are no such contingent liabilities which impact the financial position as on the date of Balance Sheet.

Previous year's figures have been regrouped wherever necessary to conform to the classification adopted in the current year.
